Alinta Apparel PTY LTD ("Alinta") Terms and Conditions of Trade:

Payment Terms:

Terms are strictly payment on delivery. Alinta does however reserve the right to grant specified credit period to any customer, at its discretion. Alinta reserves the right to charge interest on any overdue account exceeding thirty (30) days from the invoice date. Interest will be calculated daily and charged at a rate of 12% per annum.

Freight & Handling:

Unless otherwise specified, prices quoted at ex-warehouse. All relevant costs associated with carriers, post or method of transport will be invoiced to the customer's account.

Passing of title and risk:

Goods supplied by Alinta to the account holder shall be at the account holders risk immediately upon delivery. Title to Alinta products shall not pass to the account holder until the goods are paid for in full. Where the account holder has supplied the goods to a third party, and Alinta has not yet been paid for those goods, the account holder agrees at the option of Alinta to assign his claim against third party to Alinta.

Delayed Supply and Failure of supply:

Any date quoted for delivery is an estimate only and Alinta shall not be responsible for any loss (including consequential loss) suffered by the account holder, or any person, by reasons of the delay in or failure to supply any Alinta products or service.

Please also note that a 2%-5% variation on quantity (over/under) is considered fulfilment of order, and will be charged accordingly.

Cancellations:

Orders for special-make-up goods (eg. customized apparel orders), once in production, cannot be altered or cancelled.

Claims:

Product claims must be sent to Alinta for evaluation at the account holder's expense. Product which in Alinta's opinion has been abused, abnormally treated, or subject to normal wear and tear, will not be replaced. Goods to be returned shall be returned at the account holder's expense. Alinta will not accept goods sent to COD. A duplicate of the tax invoice on which the good appeared, or an applicable Claims and Repairs form must accompany the goods. Short delivers must be claimed within 24hours of receipt of the product by you.

Suspension, Cancellations or Alterations of account:

Alinta reserves the right to not supply goods to an account holder for any reason, at any time. Alinta reserves the right to change any prices and or/ Terms and Conditions of Trade at any time.

Fabric colours:

Due to the manufacturing processes involved, the account holder acknowledges that dye lot colour variations can occur in all fabrications.

Disputes:

You agree that for the purpose of these terms of trade, each agreement to supply Alinta products or services shall be deemed to have been made in the Sydney metropolitan area and you consent to any action being commenced and continued at a court or tribunal within that area. The account holder agrees to pay any legal or other costs and expense involved in recovering or attempting to recover any moneys which may be payable to Alinta. If any part of this agreement is found to be void or unenforceable, the applicant agrees that the remained of the agreement will be considered binding and enforceable.

Guarantee:

Should Alinta grant a trading account to the applicant, the signatories to the trade credit application jointly and severally irrevocably undertake as primary debtors to pay on demand any and all money that become due and payable to Alinta by the applicant.
